## GoTo® LIGHT CURE ORTHODONTIC ADHESIVE REFGTP (Push syringe) or REF GTT (Tips)

<u>INDICATIONS FOR USE:</u> GoTo<sup>®</sup> is intended for use as a light cure bracket adhesive or for creating attachments for thermoplastic aligners.

## **INSTRUCTIONS FOR USE:**

**Tooth Preparation:** Prophy the enamel surfaces to be bonded with 1st & Final® or plain oil-free pumice. Rinse thoroughly and dry teeth with oil and moisture-free compressed air.

**Etching:** With a cotton pledget or brush, dab the etching agent onto the entire area to be bonded. Allow 30 seconds for etching (60 for deciduous teeth). Avoid placing etching agent on soft tissue. Rinse and dry thoroughly.

**Primer Application:** Apply 1 coat of Assure or Assure Plus and dry with air. If Pro Seal is used, apply a thin coat and light cure the Pro Seal for 10 seconds per tooth. Proceed with application of the paste. Note: A self-etching primer may be substituted for conventional phosphoric acid etchant. Refer to self-etching primer instructions.

**Application of Paste to bracket:** Apply adhesive to bracket pad and smear into the bracket mesh. Apply bracket with paste to the etched tooth surface. Place bracket on etched tooth surface and cure adhesive at close proximity for 10 seconds\*. Once the paste has been properly cured, an active arch wire can be placed immediately.

Thermoplastic Aligners: Prophy, etch, rinse and dry the enamel. Condition the prepared enamel with Assure® Universal Bonding Resin. Apply GoTo paste into the aligner matrix, set matrix and light cure for 10 seconds\*.

\*Note: Curing times depend on the intensity of the curing light. The total curing time can range from 6 seconds to 20 seconds. Please refer to the light manufacturer for recommended curing times.

Bracket and Adhesive Removal:

To remove GoTo<sup>™</sup> use a ligature cutter to grab the adhesive at the bracket/enamel interface and pinch the bracket from the tooth. Remaining material can be removed with a Renew<sup>®</sup> Finishing System Bur and Renew<sup>®</sup> Finishing System #383 Point.

<u>CAUTION:</u> Use of UV, halogen and LED curing lights can be associated with eye damage. The patient, doctor and the assistant should wear properly designed protective eyewear when using these light curing devices.

PRECAUTIONS: Unpolymerized resins may cause skin sensation in susceptible persons. In case of contact with the skin, wash thoroughly with soap and water. If accidently instilled into eye, flush with copious amounts of water and seek medical attention immediately. Contact with other tissues: rinse spill area immediately with copious amounts of water for several minutes.

\*\* TEMPERATURE LIMITATION: Store at room temperature (15-30 Degrees C.) Allow product to reach room temperature prior to use.
